RE: Specialized Care Centre Support for LTCHs—Fulfilling Isolation

Requirements Under Directive #3 for Long-Term Care Homes

While long-term care homes in the Greater Toronto Area continue to adopt enhanced measures to prevent and manage COVID-19 outbreaks, we would like to share the details of a new support mechanism provided by the Specialized Care Centre (SCC).

The SCC can now serve to fulfil isolation equivalency requirements for admission and transfer to LTCHs as outlined in Directive #3 for Long-Term Care Homes under the *Long-Term Care Homes Act,* 2007 (Directive #3). The following groups are now included in the eligibility criteria for the SCC:

- Repatriated long-term care home residents with existing bed holding who are in the hospital and would be discharged to the SCC in order to fulfill the required 14-day isolation requirement as part of their transfer back to the long-term care home.
- New long-term care home admissions who would be temporarily admitted to the SCC to
 fulfill the required 14-day isolation requirement. These would be individuals/ patients who have
 been accepted by the long-term care home and for whom a bed has been matched and is
 available. Admissions to long-term care home and the SCC can be from the community or
 hospital.

The rigorous policies in place at the SCC are approved by the Chief Medical Officer of Health and are in line with the guidance given in Directive #3. As such, patients who fulfil their 14-day isolation requirement at the SCC can then be safely transferred to a long-term care home without requiring an additional 14-day isolation period.

Making use of the SCC for self-isolation requires the collaboration and concurrence of all parties involved—the resident, the long-term care home, public health, and the SCC. Licensees should take this into account when planning admission for residents.

This new option to work with SCC will help long-term care homes meet isolation requirements in Directive #3 and facilitate admissions to meet resident's care needs.

Residents at the SCC will be cared for by a highly skilled interprofessional team from the Toronto Grace Health Centre which is well known for its excellence in care for seniors and the elderly. We are happy to report that there has been very positive feedback in the past 3 months from residents and family members who have gone through this brief and temporary transfer to the SCC.

More About the Specialized Care Centre

The SCC works in partnership with long-term care homes, residents and their families to ensure that patient care needs are met. Personalized care plans are created that allow residents to transition very well to their long-term care home.

The SCC was created to help address the increased demand for COVID-19 outbreak support to long term-care homes in Toronto, York, Peel and Durham regions. It has since been expanded to include Simcoe-Muskoka and Halton Region. The SCC has 90 beds staffed by Toronto Grace Health Centre. The SCC is located in the Toronto Congress Centre at 650 Dixon Road in Etobicoke.
